8. Grant is VAT included, bidders to price with VAT.
9. A site Visit and Pre-Bid Meeting: Contractors are invited to attend the site visit which will **be held on Wednesday 29-08-2018 at 10:00 AM, the pre-bid meeting shall be held at Bethlehem Municipality, Head of Planning and Projects Department/ after finishing site visit.**
10. Bids shall be valid for a period of 90 after Bid closing and must be accompanied by a bid security of **^,000 Euro** and shall be valid for 118 days after bid closing date.
